The Directors have been working with the Chinese Government pig farms to negotiate a deal for the conversion of the farms in the Region. These negotiations have been longer and more difficult than first expected. This has had an adverse effect on the Revenue and costs of the organization.

Planned introduction of the LETU product to the Australian market has been put back due to initial difficulties with the immigration Department and the Australian Quarantine Inspection Service.

At the date of signing this document the Directors have been advised verbally that the Australian Quarantine Inspection Service has approved the importation of the LETU into Australia. Also the Immigration Department has issued Visas for the technical staff to come into the country to supervise the first farm conversion here in Australia.
