We are pleased to forward you our fully franked maiden dividend of 1 cent for the half year.

Since listing on the Newcastle Stock Exchange in September last year, the Directors have been actively placing shares to acquire additional listed securities and to raise cash to fund the activities of the company for investment opportunities. Such placements have been done at a 50% premium to the initial listing price and to date in excess of 1 million shares have been placed. The company's balance sheet remains strong with in excess of \$750,000 cash on deposit. The strategic investment portfolio has a market value of approximately \$1.5 million and the company has no borrowings.
