Due to the timing of Tattersalls Limited listing on the ASX, only one dividend distribution was received by Rattoon from this investment in FY2006. In the normal course of events, the Company would expect two dividend distributions per annum.

A description of each event since the end of the current period which has had a material effect and is not related to matters already reported, with financial effect quantified (if possible)

The Board has made the following recommendations to Shareholders:

- a) That Rattoon acquires 21,7500,000 shares in Tattersalls Limited from GPG Australia Nominees Limited, payment for which will be via a combination of cash and ordinary shares in Rattoon
- b) That Rattoon acquires 21, 750,000 shares in Tattersalls Limited from interests associated with the Thorney Investment Group, payment for which will be via a combination of cash and ordinary shares in Rattoon.
- c) That Rattoon undertakes a capital raising for a maximum of \$8 million upon the issue of ordinary shares in Rattoon.

These recommendations will be put to a General Meeting of Shareholders on September 28, 2006.

There have been no other events that have arisen in the interval between the end of the financial year and the date of this report, or any matter or circumstance, that in the opinion of the Director's of the Company has significantly affected, or may significantly affect, the operations of the Company, the results of those operations, or the state of affairs of the Company, in future financial years.

Franking credits available and prospects for paying fully or partly franked dividends for at least the next year

At 30 June 2006 the Company had a franking account balance of \$854,907. The Company is hopeful of paying a fully franked dividend in FY2007, subject to the shareholders approving the recommended transactions at the General Meeting scheduled for 28 September 2006.

The requirement under the list rules for an *issuer* to complete this statement does not prevent the *issuer* issuing reports more frequently. Additional material lodged with the *ASIC* under the *Corporations Act* must also be given to the Exchange. For example, a *directors*' report and statement, if lodged with the *ASIC*, must be given to the Exchange.
- 13. **Accounting Standards** the Exchange will accept, for example, the use of International Accounting Standards for *foreign issuers*. If the standards used do not address a topic, the Australian standard on that topic (if one) must be complied with.
- 14. **Borrowing corporations** As at 1/7/96, this statement may be able to be used by an *issuer* required to comply with the *Corporations Act* as part of its half yearly financial statements if prepared in accordance with Australian Accounting Standards. However, borrowing corporations must comply with Schedule 5 of the Corporations Regulations. See regulation 3.6.02(4).
