**HERITAGE GOLD WARRANT CONVERSION**

Heritage Gold NZ Limited ("Heritage") has completed the conversion of 1,804,859 warrants to ordinary fully paid shares. These shares rank equally in all respects with the existing ordinary shares of Heritage.

There are 20,421,737 warrants remaining on issue.

Heritage is also listed on the ASX and the National Stock Exchange of Australia (formerly Newcastle Stock Exchange). The company has valuable gold assets in the Waihi district of New Zealand, where it is a major tenement holder. Heritage also owns 33% of Broken Hill Cobalt Ltd in Australia and has applied for permits to prospect for gold, silver, copper, and base metals in Northland, about 150km north of Auckland. Recently Heritage has entered into a joint venture to explore for uranium in the Dunmarra Basin of the Northern Territory.
