Corpnet Implements Stage Two of Brisbane Airport Corp Deal

EBS subsidiary Corpnet is nearing completion of its current data storage project for Brisbane Airport Corporation.

Stage one of the project began in May, and work on stage two has been in progress since mid-July.

BAC operates and develops Brisbane Airport under a long-term lease from the Commonwealth of Australia. There are 320 businesses and nearly 17,000 people work on Brisbane Airport every day. This is forecast to exceed 50,000 people by 2029.

With so many business and people relying on BAC being operational it is vital that their IT systems are up to the task. A key aspect is robust infrastructure & disaster recovery plans in case of any critical system failure.

The solution implemented by Corpnet utilises BAC's existing HDS infrastructure and VMware's Site Recovery Manager. Corpnet are locally one of the most experienced integrators of HDS & VMware.

BAC IT Systems Manager, Stephen Tukavkin says the VMware solution will enable BAC to facilitate regular planned tests of the disaster recovery process with minimal management overheads.
