

DIRECTOR'S DECLARATION AND UNDERTAKING

DECLARATION

1. I state as follows:
 - (a) My full name is Robert Keith Stewart.
 - (b) I have no former names.
 - (c) My date of birth is 20 March 1946.
 - (d) My residential address is 25 Quirk Street, Rozelle, NSW 2039.
 - (e) My nationality is Australian.
2. I am not a director, alternate director or compliance committee member of any other corporation which is publicly listed or traded or a partner in any partnership.
3. I have not been adjudged bankrupt in any jurisdiction.
4. At no time have I been a party to a scheme of arrangement or made any form of composition with my creditors.
5. There are no unsatisfied judgments against me.
6. No corporation has been put into compulsory liquidation or had an administrator or receiver appointed during the period when I was (or within the preceding twelve months had been) one of its *directors*, alternate *directors* or compliance committee members. Nor has any partnership been put into compulsory liquidation or been sequestrated during the period when I was (or within the preceding twelve months had been) one of its partners.
7. At no time have I or has any corporation of which I was a director, shadow director, alternate director or compliance committee member at the time of an offence, been convicted in any jurisdiction of any criminal offence or an offence under legislation relating to companies.
8. I have not, in connection with the formation or management of any corporation, managed investment scheme, partnership or unincorporated institution, been adjudged by a court in any jurisdiction civilly liable for any fraud, misfeasance or other misconduct by me towards it or towards any of its security holders.
9. I have never been disqualified by a court from acting as a director of a corporation, as a compliance committee member or from acting in the management or conduct of the affairs of any corporation.
10. I have not, in any jurisdiction, been refused admission to or renewal of membership of any professional body, trade society, institution or association, or stock exchange or been censured or
