Sale of Parkes Shopping Centre

APN Funds Management Limited as responsible entity for the APN Regional Property Fund (the **Fund**) is pleased to announce the sale of the Parkes Shopping Centre.

A contract has been exchanged to sell the property for \$10.2 million which is equal to its book value as at 30 June 2014. Settlement is expected to occur around 15 January 2015.

Initially the net sale proceeds will be applied to debt reduction resulting in the Fund's loan to value ratio reducing to below 40% and a 0.05% pa reduction in the Fund's interest rate margin on the remaining loan.

The sale of Parkes Shopping Centre is consistent with the Funds' previously outlined strategy, an update of which will be provided following the completion of half year reporting in March 2015.
