MOUNT ROMMEL MINING LTD - INFORMATION RELEASE

Please be advised as follows -

- 1) As per the conditions under which concession EL 5492, and prior MIN 5391, were granted for the present term of those concessions, the Company renewed its drilling activity at Clunes. Some of the outcomes of that activity were forwarded to NSX earlier today, and more will follow in due course.
- 2) Many different companies have been previous holders of like concessions from State Government. Previous drilling at Clunes has had various results, much of which was either discouraging, or not in accord with expectations at the time. The choice of sites for earlier drilling apparently over-looked certain archival information, pointing clearly to prospective areas.
- 3) The commercial objectives for so much of the repeated interest by companies over the past 65 years has been clearly set out in the small publication authorized formally by former Councillors, the old Borough of Clunes, in year 1902. This publication is available at the State Public Library of Victoria - call # S 622.3421 G 36..., titled "*THE CLUNES MINES*"- probably available through on-line enquiries of SLV.
- 4) Readers of the SLV reference quoted above, and of other supporting work by people associated with Mount Rommel, will quickly appreciate substantial tonnages could come from understanding where offsets of a once-famous vein known as "Robinson's" might be found - or any other of the once publicly recognized veins.
- 5) Mount Rommel drilling at present sets out to reveal what actually happened to Robinson's gold-bearing structure, south of the former Port Phillip South shaft, and to better delineate a flatter-dipping link structure to the immediate east of Robinson's intersected by drilling in 2006 and 2007.

Present position --

- Current drill hole CD15-03 has intersected substantial interval(s) of fractured, mineralized quartz, one of which is thought to be "Robinson's Vein".
- Directors have arranged for other professionally qualified individuals (who are not shareholders of the Company) to view and consider the core from current drilling, and review some portions of core from year 2006 and 2007. The reviews will occur over 2 days, being 16 and 17 February, 2015 at Allendale core shed, and at Clunes, in the presence of Directors.
- Water pumped from the sub-surface mine environs has been collected as EPA specifications require for quality analysis, and forwarded to a NATA laboratory.
- Recent geophysics, supported by gold assays of samples from a pit excavated 4 December 2014, resulted in the making of a written request to Council, 4 February 2015, for permission to drill under Scenic Drive. A response is awaited.

More information will be provided as it comes to hand.
