Dear Shareholder / Grower,

Capital Structure Review: March meetings to discuss potential model and tour SunRice mills

The SunRice Board has been engaged in a comprehensive process to review SunRice's capital structure and develop a potential model for the future that underpins our company's growth, while preserving the rights of A Class shareholders and enhancing the value of B Class Shares.

This stage of the review is now complete and we wish to invite you to attend shareholder and grower meetings in March to discuss a potential capital structure which is unique to SunRice and meets our non-negotiable around preserving grower shareholder control on an ongoing basis. In these meetings your Directors will explain the model and its features and seek your feedback in determining next steps.

To ensure as many people as possible have the opportunity to understand the model, ask questions and provide comments, we will be holding a range of different types of meetings:

- 3 5 March 2015: Formal meetings at the RRAPL Field Day and in Leeton and Deniliquin. Following feedback, the Leeton and Deniliquin meetings will also incorporate tours of SunRice operations (including the \$9.8 million capital upgrade to the Leeton retort microwave rice plant), a BBQ dinner and bus transport from Griffith and Coleambally. In addition, those shareholders who RSVP for the mill tours will be given a new pair of steel cap boots to use on the tour and take home.
- **6 March 2015:** A Q&A technical workshop will be held in Jerilderie to discuss the proposed structure in detail following the formal meetings. We encourage you to attend with your accountant and/or financial advisor.
- 9 12 March 2015: Informal small group shed meetings on people's farms and other locations to give you the opportunity to ask further questions and provide feedback. We encourage you to nominate to host a shed meeting in your area for your family, peers, neighbours and others using the RSVP form attached. Every effort will be made to accommodate these meetings wherever practical.
- **6pm, 9 March 2015:** If you are unable to make one of the Riverina meetings you can also opt for a webinar presentation, followed by a Q&A.

Please find an initial schedule of meetings and tours on the following page for your consideration. We ask that you attend the meetings that best suit you and that you confirm your attendance by returning the form to us by **Wednesday 25 February 2015.**

Please note all SunRice growers and shareholders – A and B, grower or non-grower – are welcome at these meetings, as are your financial advisors should you wish to invite them. Refreshments and catering will be provided at all meetings to accommodate those of you coming straight from the farm or work.

The Board and I encourage you to attend one of the large shareholder sessions, as well as hosting a shed meeting. These meetings are important in determining the future of SunRice and the next steps in the Capital Structure Review process. You are of course welcome to contact me at any time with your questions. We look forward to your participation at one or more of the meetings in March.
