TIMAH RESOURCES LIMITED - close of Public Offer

Timah Resources Limited (**Company**) is pleased to announce that its public offer under its Replacement Prospectus dated 6 July 2015 and Supplementary Prospectus dated 12 August 2015 (**Public Offer**) has closed at 5pm today.

The Company has received subscriptions for 605,000 ordinary shares at \$0.20 per share to raise \$121,000. The issue of these shares is still conditional on ASX's approval for the admission of the Company's shares to the official list of ASX becoming unconditional.
