 involvement progressed from cutting cane by hand to the development and operation of mechanical cane
 harvesting equipment.
- I subsequently also purchased my own cane property and worked both businesses until election to State Parliament in 1994.
- I was a delegate to the sugar industry conferences for 24 years. I served five years on the board of a growers
 organization with three years as chairman until April 1994. In this role I was a member of the Sugar Industry
 Policy Council and the Sugar Research and Development Corporation Selection Committee and was involved
 in discussions leading up to the division of sugar moneys.
- Other business interests include cattle, earthmoving, residential development and construction.
- I was elected to the Queensland Parliament at a by-election in April 1994 representing the seat of Mirani. I was returned as the Member for Mirani at seven consecutive State elections in 1995, 1998, 2001, 2004, 2006, 2009 and 2012.
- I was Assistant Minister for Police and Emergency Volunteers during last term of Parliament.
- Shade Ministries held over the previous 19 years in Parliament included Public Works and Housing, Employment and Training, Local Government and Planning, Communities, Seniors, Disability Services, Northern Development and Emergency Services. I retired as the Member for Mirani in January 2015.
- Was a member of numerous Parliamentary Committees and Trade Delegations during my 21 years in the Queensland Parliament.
