RE: PROPOSED LISTING ON THE NATIONAL STOCK EXCHANGE OF AUSTRALIA LIMITED
- E-PLUS LIMITED (ACN 605 951 059) ("E-PLUS" or the "Company")

E-Plus is proposing to apply for the listing of and quotation for all its ordinary fully paid up shares on the National Stock Exchange of Australia Limited.

We set out below the relevant requested information of our Company for your kind consideration:

1. General

- (1) the name of the applicant and the date and place of incorporation;**

E-PLUS LIMITED (A.C.N 605 951 059) is a company incorporated in Australia and registered in Victoria on 20 May 2015.

- (2) if not incorporated in Australia, the date on which the applicant became registered under the Corporations Act;**

- (3) the address of the principal registered office and the address of each office at which a share register is kept;**

The registered office of the Company is located at Level 12, 225 George Street Sydney NSW 2000.

- (4) a formal request for the listing of the securities in respect of which application is made, specifying the nature of the securities and the amount, class, the voting rights attached and whether they are to be fully paid;**

We formally request listing of the Company's fully paid ordinary shares. The 245,000,000 Shares in issue by the Company are fully paid Ordinary Shares ("Shares") having the rights as prescribed by the Constitution of the Company. The holders of

Shares in the Company are entitled to one vote per share in a General Meeting on any matter that can be voted upon by the Shareholders. The holders of Shares have no pre-emptive or other rights to subscribe for additional Shares. Please refer to Section 5 of the Information Memorandum for further information on the rights attaching to the Shares.

- (5) the proposed method by which the securities are to be brought to listing and details of any proposed distribution of the securities;**

The Company is proposing a compliance listing. As at the date of this application, the Company has 60 shareholders.

No new capital was raised or available to the Company as a result of this listing. The listing of the Shares may have favourable consequences for the Company's shareholders who may wish to trade their shares through a stock exchange. The Listing of the Shares on the NSX may also provide access to an efficient facility for executing any future transactions in Shares of the Company.

escrowed for 12 months or 24 months, depending on the relationship of the shareholder to the Company.




