## **NSX - MOUNT ROMMEL ACTIVITY- CLUNES GOLDFIELD DISCLOSURE OF INFORMATION - CURRENT AS AT 5 MARCH, 2017**

Mount Rommel Mining Ltd. is working towards becoming the sole holder of rights to future gold along the known Clunes Goldfield, and in immediately adjacent areas.

The southern section of this goldfield extends south of the Clunes Talbot Road, over all the known workings of the former South Clunes United gold mine.

This southern part also has a western component, being an area not drilled, but described to some extent by the gold production from old workings on the elluvial surface, well below the present natural surface. Geophysics in year 1965 (I.P. by WMC) directs attention to this same western area, as does geophysics (micro-gravity) on several occasions, prior to 2005.

Holding rights to the whole extent of the southern section to Clunes Goldfield - known and presumed - are believed to fall within the bounds of an exploration licence application EL 6406.

Application EL 6406 has been in progress since 18 October, 2016. The application was made in the name BONSHAW GOLD PTY. LTD. (ACN 112 035 006) a wholly owned subsidiary of Mount Rommel Mining Ltd. Following statutory proceedings, this application EL 6406 was duly advertised on 25 January, 2017, including that information provided on the Home Page of the web-site of this Company.

The information disclosed today is as follows -

1. The Company Secretary has email confirmation from a Government officer that no objections were lodged with Government, in the statutory period set by the advertisement.
2. The Director of Bonshaw Gold Pty. Ltd. received a letter from Government, dated 16 February, 2017, advising the applicant of EL 6406 that the entire area of that licence is within the Dja Dja Wurrung Recognition and Settlement Area.
3. In order for the matter to progress, the applicant has been given 28 days from 16 February 2017 to consent to the inclusion *in the intended licence document* of certain standard conditions in respect of Native Title.

The Government correspondence makes clear that without that given consent, the application may be refused.

The dealings between the State of Victoria and the Dja Dja Wurrung Clans Corporation were signed off on 5, 8, and 14 March 2013, made effective *for everyone* 25 October, 2013. Details are available on the internet - see Google, at LUAA Victoria.

Given the available information, the sole means of development within the broader Clunes goldfield requires any like application to follow the process as we have done. A letter from Bonshaw Gold - providing the required consent - has been forwarded to the Native Title Co-Ordinator, Earth Resources Regulation, at Government Offices, Ballarat.

It is appropriate to leave these matters now take their course.

Work completed provides a sufficient basis to delineate very good targets for drilling. This exploration data is withheld, awaiting the actual grant of EL 6406.
