### How to Vote on Items of Business

Each CHES Depositary Interest (CDI) is equivalent to one share, so that every 1(one) CDI that you own at 25 May 2017 entitles you to one vote.

You can vote by completing, signing and returning your CDI Voting Instruction Form. This form gives your voting instructions to CHES Depositary Nominees Pty Ltd, which will vote the underlying shares on your behalf.
