### FY17 Financial Results

APN Funds Management Limited as responsible entity for the APN Regional Property Fund (the **Fund**) is pleased to announce the Fund's full year financial results for the year ended 30 June 2017.

#### Key Highlights:

- Net Profit was \$4.72 million for the year ending 30 June 2017;
- Net tangible assets at 30 June 2017 is \$1.19 per unit, an increase of 7.2% from 30 June 2016;
- The Fund's loan to valuation ratio decreased from 34.5% at 30 June 2016 to 33.1% at 30 June 2017;
- The Fund's weighted average lease term to expiry (WALE) decreased by 0.9 years to 2.5 years (by income) as at 30 June 2017; and
- The Fund's portfolio was independently valued as at 30 June 2017 as set out in the table below:
