Refer your letter dated November 3, 2017 please note our answers as follows:

- 1. Anchor Capital Investments Ltd. only became aware of the BaFin warning from 18 months ago via the suitability investigation of the last two months. However, trading was never suspended by Deutsche Bourse, nor has BaFin responded to our attorney's request for their findings. Again, when we became aware of the warning, we acted to post a statement disclosing the suitability investigation of NSX on the company web site. Since NSX was the source of our information on BaFin, we perhaps wrongly concluded that we did not need to act further on the NSX site.
- 2. There was nothing in the brief warning announcement that the board felt required any more response that in the attorney letter firmly stating that no market manipulation or cold calling had occurred as a result of company actions.
- 3. The company desires to establish protocols that will keep us all better informed on a continuing basis.
