## **Periodic Disclosure Query**

The National Stock Exchange of Australia (NSX) refers to the 2017 Annual Financial Report<sup>1</sup> lodged on 2<sup>nd</sup> April 2018 on which we have made the below observations:

 Total assets reported for the period ended 31 December 2017 is AUD\$14,137,534. Trade and other receivables reported for the same period is AUD\$11,701,100 which represents approximately 83% of the Company's total assets.

In Note 9<sup>2</sup>, the Company explained that the Trade and other receivables consist of two parts: Trade receivables (AUD\$138,128) and Other receivables (AUD\$11,562,972).

Receivables impairment has been highlighted as a key audit matter in the 2016<sup>3</sup> and 2017 Annual Reports. The Company is requested to provide below information given the size and significance of the Other receivables reported for the last 3 financial years have been consistently high.

- 1. Please provide a detailed breakdown of Other receivables (AUD\$11,562,972).
- 2. Please provide an Aging analysis for Trade and other receivables for 2016 and 2017.
- 3. Please provide a summary, in the form of a comparative table, of the results and of the assets and liabilities of the group, for the last five financial years.

Your response should be provided no later than 4pm AEST on 16<sup>th</sup> July 2018. Your response will be released to the market along with a copy of this letter. If you wish to discuss the content of your response, please do not hesitate to contact me as soon as possible.

Please be reminded that the Issuer must comply with Chapter 6CA of the Corporations Act and Listing Rules Section IIA 6.4, 6.5 and 6.5A under continuous disclosure.
