4. History and Nature of the Business Introduction

The Company is currently an unlisted public company. While the Company is not proposing to raise capital pursuant to the Prospectus, the NSX listing offers:

- existing shareholders access to a national trading platform for their shareholding in the Company;
- the ability for the Company to offer listed script to employees and future users of the Software should it decide to do so;
- a platform to raise capital in the future; and
- another milestone in the ongoing development of the Company.



Company Overview

SenterpriSys Limited ("SenterpriSys" or the "Company") was originally a 100% owned subsidiary of Tamawood Limited ("Tamawood") and was formerly known as Resiweb Limited.

In April 2012, Tamawood divested its equity interest in the Company via an in-specie distribution to its shareholders. Tamawood remains a shareholder with 23.56% holding in SenterpriSys.

The Company is developing an integrated enterprise management software program ("Software") designed to improve processes and end-to-end functionality for small to medium home builders as well as other small to medium enterprises. The Software is based on the proprietary home building software of Tamawood.

SenterpriSys has lodged patent applications in Australia to protect the Software and plans to commercialize the Software using the "software as a service" business model. The patent application are currently pending approval.

In addition to the development of the Software, SenterpriSys is responsible for the on-going suppoer of Tamawood's project management software, including back-office and client interface processes. SenterpriSys also provides back office support to AstiVita Limited.

Senterprisys Builder

The application being developed for use by small to medium home builders is called SenterpriSys Builder. Currently, SenterpriSys Builder is in the advance stages of development and undergoing "beta" testing.

Members of the Australian Housing Industry Association ("HIA") have shown interest in SenterpriSys Builder as a means to address the increasing compliance and regulatory pressures confronting HIA members in the Australian home building industry.

SenterpriSys Builder is primarily designed to improve regulatory compliance, increase productivity and speed up construction processes.

SenterpriSys Builder is a program designed to cater to the needs of small to medium builders and suppliers, from first contact with clients, to appointments, job details, estimating and contracts, colour selection, interacting with the HIA, project management, payments and ordering.


The Customer Relationship Management module allows users to work on different aspects of the project lifecycle including appointments, creating jobs, progress payments, documents, letters, emails, C3S web portal, SMS update to customers and suppliers as well as records of remarks related to site requirements, contracts and banks. The interface offers users many features to ease work flow over a project lifecycle.



