### PORTFOLIO COMMENTARY

Dawney & Co's pre-tax NTA per share was up 2.8% in the month of September.

The end of September marks 3 years of operating history as Dawney & Co Ltd. In that time we have earned cumulative returns of 42.4% before tax, net of all expenses versus the All Ordinaries Accumulation Index of 34.9% over the same period. Presentation of investment returns varies amongst managers so for illustration purposes and comparing apples with apples we thought it would benefit shareholders to highlight both compound annual growth rate and annualised figures:

It was an active month for the portfolio. We exited Bowen Coking Coal, realising \$908k from a \$271k investment (a 234% return in roughly 2 years). We increased our holdings in Western Areas and KPT and initiated positions in Quantum Health and Jindalee Resources. We also participated in the High Peak Royalties Placement.

We sold out of some of our smaller non-performing holdings and trimmed our AF Legal Group.
