Variation of Illuminator Bidder's Statement – Extension of Offer Period

We refer to the Bidder's Statement lodged with ASIC on 9 February 2023 in relation to the off-market takeover offer by Illuminator Investment Company Limited (ACN 107 470 333) to acquire all of the fully paid ordinary shares in Florin Mining Investment Company Limited (ACN 111 170 882) (**Bidder's Statement**).

Capitalised terms otherwise undefined in this announcement have the meaning given to the same term in the Bidder's Statement.

In accordance with sections 650D(1) and 650C(1) of the Corporations Act, Illuminator makes the following variations to the Offer (**Variations**):

- (a) extending the period during which the Offer remains open for acceptance from 7:00pm (Sydney Time) on 27 March 2023 to 7:00pm (Sydney Time) on 24 April 2023 (unless further extended or withdrawn); and
- (b) substituting the date "27 March 2023" with the date "24 April 2023" in the Bidder's Statement, the Acceptance Form and in all other instances where "27 March 2023" appears (or is deemed to appear) as the Closing Date of the Offer.

A copy of the Notice of Variation, which gives effect to the Variations, is **attached** to this announcement.

Pursuant to section 360(2)(b) of the Corporations Act, Illuminator further provides notice that the new date for the giving of notice on the status of conditions in relation to the Offer will be 17 April 2023.

Unless otherwise defined, capitalised terms used in this notice have the meaning given to the same term in the Bidder's Statement.

1. Extension of the Offer Period

Illuminator gives notice pursuant to sections 650D(1) and 650C(1) of the Corporations Act that the Offer is varied as follows:

- (a) extending the period during which the Offer remains open for acceptance from 7:00pm (Sydney Time) on 27 March 2023 to 7:00pm (Sydney Time) on 24 April 2023 (unless further extended or withdrawn); and
- (b) substituting the date "27 March 2023" with the date "24 April 2023" in the Bidder's Statement, the Acceptance Form and in all other instances where "27 March 2023" appears (or is deemed to appear) as the Closing Date of the Offer.

2. New date for giving of notice as to status of conditions

Given that the Offer Period is extended as set out above and that the Offer remains subject to the Defeating Conditions outlined under clause 7.1 of Annexure A of the Bidder's Statement, Illuminator gives notice in accordance with section 630(2)(b) of the Corporations Act that:

- (a) the Bidder's Statement is varied so that the new date that Illuminator is required to give notice of the status of the defeating conditions is 17 April 2023; and
- (b) as at the date of this notice, so far as Illuminator is aware, none of the Defeating Conditions set out in clause 7.1 of Annexure A of the Bidder's Statement have been fulfilled or waived and accordingly the Offer remains subject to those conditions.


3. Date of lodgement and disclaimer

A copy of this notice was lodged with ASIC on 20 March 2023. ASIC takes no responsibility for the contents of this notice.
