### Variation of Illuminator Bidder's Statement – Extension of Offer Period

We refer to the Bidder's Statement lodged with ASIC on 9 February 2023<sup>1</sup> (**Bidder's Statement**) in relation to the off-market takeover offer by Illuminator Investment Company Limited (ACN 107 470 333) to acquire all of the fully paid ordinary shares in Florin Mining Investment Company Limited (ACN 111 170 882) (**Florin**).

Capitalised terms not defined in this announcement have the meaning given to the same term in the Bidder's Statement.

In accordance with sections 650D(1) and 650C(1) of the Corporations Act, Illuminator makes the following variations to the Offer (**Variations**):

- (a) extending the period during which the Offer remains open for acceptance from 7:00pm (Sydney Time) on 9 October 2023 to 7:00pm (Sydney Time) on 6 November 2023; and
- (b) substituting the date "9 October 2023" with the date "6 November 2023" in the Bidder's Statement, the Acceptance Form and in all other instances where "9 October 2023" appears (or is deemed to appear) as the Closing Date of the Offer.

A copy of the Notice of Variation, which gives effect to the Variations, is **attached** to this announcement.

### Final extension

**This is the final extension, and the Offer period will not be extended beyond 6 November 2023. The Offer is unconditional and will close on that date regardless of the level of acceptances received by the close of the Offer.**

Given the small number of remaining shareholders of Florin and the controlling shareholding already held by Illuminator, following the close of the Offer Illuminator intends to examine options to delist Florin from NSX.


