# 1 **CORPORATE INFORMATION**

The interim financial statements of I M Quarries Limited for the financial period ended 30 September 2023 were authorised for issue on the date of the Statement by the Directors.

I M Quarries Limited is a public company limited by shares incorporated in Singapore and listed on the National Stock Exchange of Australia.

The registered office of the company in Singapore is located at 22 Sin Ming Lane, #06-76 Midview City, Singapore 573969.

The principal activity of the Company and its controlled entities (the "Group") is to carry on the in exploration and mining for natural resources (particularly industrial grade garnet) and its ancillary activities.

#### 2. NATURE OF OPERATIONS

The Company has not actively carried on business since it was registered on 30 August 2011 to the date of this report.

#### 3. GENERAL INFORMATION AND BASIS OF PREPARATION

The interim consolidated financial statements are for the six months ended 30 September 2023 are presented in Singapore Dollars which is the Company's functional currency. They have been prepared in accordance with IAS 34 *Interim Financial Reporting*. They do not include all of the information required in annual financial statements in accordance with IFRS, and should be read in conjunction with the consolidated financial statements of the Group for the year ended 31 March 2023.

I M Quarries Limited is the Group's ultimate parent company. The Company was incorporated under the laws of Singapore as a public company limited by shares.
