- A positive step forward in advancing the company to its next phase in the discovery of precious and critical minerals.




### **Granted Exploration License**

The granted tenements are located in the Yalgoo Mineral Fields (Western Australia) approximately 110 km southeast of Mount Magnet.

## Geology

The tenements are located in the Murchison Domain of the Yilgarn Craton. Archaean maficultramafic layered igneous intrusions and associated dykes and sills comprise about 40% of the greenstones in the northern Murchison Domain of the Youanmi Terrane. The southern cluster of tenements is dominated by the second largest of these igneous intrusions, the Narndee Igneous Complex.

#### **Next Steps**

With **RSC Mining and Exploration** (RSC), we've commenced on-site inspections of granted tenements to assess geological and operational conditions. At present, our team is on the ground investigating significant geological anomalies with historical relevance. RSC will also perform a thorough desktop study of promising exploration areas.
