QUARTERLY UPDATE ON ACTIVITIES FOR THE QUARTER TO 31 DECEMBER 2025

Key Highlights

- Unaudited sales revenue for the 3rd Quarter ending 31 December 2025 amounted to \$ 1,533k.
- Sales revenue for the quarter was mainly from the domestic market with E-commerce sales contributing 51% and Media and Advertising fee contributed the remaining 49%.
- Cash at the end of the quarter was \$17k.
- The net cash outflow for the quarter was \$101k, comprising of:
 - 1) The net cash inflow from operating activities for the quarter was \$96k. During the quarter \$795k in cash receipts were received from customers. There are cash payments related to operating activities amounting to \$699k. These payments mainly comprised:
 - a) Staff costs - \$63k.
 - b) Advertising and marketing costs - \$228k.
 - c) Purchase of goods and services - \$420k.
 - 2) The net cash outflow from investing activities for the quarter was \$191k. This is mainly due to the payment of other non-current assets (\$184k) and physical non-current assets (\$7K).
 - 3) The net cash outflow from financing activities for the quarter was \$6k. This is from the repayment of borrowings.

Corporate Activities

- There is no issue of shares during the quarter ended 31 December 2025. As of 31 December 2025, the company had 154,500,000 listed shares on issue.

Payments to Related Parties

Cash payments for directors' remuneration during the quarter were \$20k.
