How to Vote on Items of Business

Each CHES Depositary Interest (CDI) is equivalent to one share, so that every 1(one) CDI that you own at 23 May 2016 entitles you to one vote.

You can vote by completing, signing and returning your CDI Voting Instruction Form. This form gives your voting instructions to CHES Depositary Nominees Pty Ltd, which will vote the underlying shares on your behalf. You need to return the form no later than the time and date shown above to give CHES Depositary Nominees Pty Ltd enough time to tabulate all CHES Depositary Interest votes and vote on the underlying shares.

Signing Instructions
