First business crowdfunding project in Australia

Australian listed crowdfunding platform CoAssets Limited ("CoAssets" or the "Company") (NSX code: CAX), is pleased to report completion of the Company's first Australian small-to-medium enterprise (SME) business lending crowdfunding project in Australia. CoAssets raised more than \$105k in less than two days.

The project was for an Australian SME, Stapleton International, which provides consultancy service solutions to the Engineering and Construction Industries, and needed available and rationally priced financing without lengthy initial delays to commence a contract to provide professional services to a major Australian oil & gas project. Therefore Stapleton went through CoAssets to raise the funds needed. In just two days, Stapleton raised more than \$105k from investors online, which was more than the amount they needed.

Stapleton also set the returns it wanted to offer, with a 7 month term of the loan and 5% interest, and crowdfunding investors were attracted by the return on the deal. SME crowdfunding is becoming an alternative to lengthy to obtain bank financing, especially the funding gap CoAssets addresses of \$100k to \$5 million for SME sized companies.

Commenting on the deal, Dr Mick Thurlbeck, Managing Director at Stapleton International:

"From initial contact and with all activities to reaching final agreement, I was most impressed with CoAssets. Their professionalism in helping us to achieve our crowdfunding target was excellent and I would strongly encourage other SMEs looking for loans to crowdfund through them too. I will not hesitate to use them again as this crowdfunding has provided us with a perfect opportunity to stimulate our company growth."

"The speed of execution was really impressive with this deal, as it just took two days to raise the funds, less than it would usually take via banks.
