How to Vote on Items of Business

Each CHESS Depository Interest (CDI) is equivalent to one share, so that every 1(one) CDI that you own at 21 June 2016 entitles you to one vote.

You can vote by completing, signing and returning your CDI Voting Instruction Form. This form gives your voting instructions to CHESS Depository Nominees Pty Ltd, which will vote the underlying shares on your behalf. You need to return the form no later than the time and date shown above to give CHESS Depository Nominees Pty Ltd enough time to tabulate all CHESS Depository Interest votes and vote on the underlying shares.

Signing Instructions

Individual: Where the holdings is in one name, the security holder must sign.

Joint Holding: where the holding is in more than one name, all of the security holders should sign.

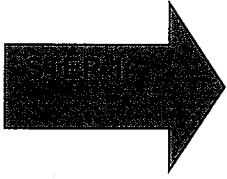
Power of Attorney: If you have not already lodged the Power of Attorney with the Australian registry, please attach a certified photocopy of the Power of Attorney to this form when you return it.

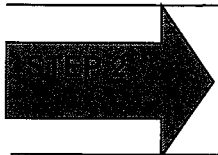
