Debenture Holders to vote on 11 August 2016 to extend the "run-off" of the debenture fund

On Friday 22 July 2016, Justice Beach of the Federal Court of Australia ordered that Angas Securities to hold a meeting of its debenture holders on August 11, 2016 to consider a proposal for a six month extension to the "run-off" of the company's legacy debenture fund.

The meeting and vote will be conducted at both Adelaide Convention Centre and the Perth Convention Centre. Explanatory statements will be distributed to all debenture holders on 26 July 2016.

Since the August 2015 meeting of debenture holders approved the "run off", Angas has sold 44 security properties and received 48 part or full loan discharges - enabling payment to debenture holders of \$74.575 million in principal and \$8.519 million in interest. Assets realised to date by Angas Securities have returned more than \$3 million above valuations included in the August 2015 explanatory memorandum to debenture holders.

In the meantime, Angas Securities will continue to report to and consult with the Loans Realisation Committee established following the meeting of debenture holders last year. Both Angas Securities and the Trustee for Debenture Holders are represented on the Loans Realisation Committee. John Powell, its independent Chairman, was appointed by the Federal Court of Australian last year.
