

## LOCAL TELCO ANNOUNCES ANOTHER STRONG INTERIM RESULT

Bendigo Community Telco (BCT) is pleased to announce another solid interim profit result for the first half year ended 31 December 2008. Given the current economic climate Directors feel confident that our shareholders will be pleased the company has again provided a strong interim dividend of 5 cents per share. The company also made a number of substantial capital investments to enhance the range of services and its prospects, and to secure future revenue growth.

The interim profit result is down on the previous comparable reporting period due in part to the intensive competition and repricing in the Telco industry. The result also included a number of accounting adjustments none of which were of a material nature to both the current and prior reporting periods. "Considering the current economic climate, and our decision to continue to invest strongly into the business, we are pleased with the half-yearly profit result," Mr Hunt said.

Bringing competition to the Bendigo region was one of the strong drivers in starting a local telco, and we are continuing to do our job points out Chairman Rob Hunt. He also points out that given the current economic circumstances the company has produced a respectable profit result, while adding to its capacity to enhance the services it is able to provide to its existing and prospective customers. The chairman expressed his thanks to all customers and the community for their continued support of this important local enterprise.

Mr Hunt said, "Now in our ninth year of operation, it is pleasing to see that our focus on our customers' success and the success and resilience of our local Bendigo economy, together with the strategic advantage our business brings in terms of competition and price, continue to be the

real contribution in our local economy. We have increased local employment, increased	<
competition in our market, we are retaining local capital in our economy, and we are deciding the	
priorities that we need addressed at a local community level.	П

and we will work through these challenging times with our customers. We are confident BCT will	
continue to produce solid results, and that our focus on serving our customers and the

CEO Phil Lazenby said, "In these ever changing times we see the need to focus on adding value in	
our customers' businesses, above and beyond traditional fixed lines, mobiles and data services."	
Mr Lazenby said the Telco's team of specialist technicians provides invaluable network and	
infrastructure advice to its customers, adding, "This means that businesses with limited IT or	
technical expertise can remain up to date with the latest in technology, gain access to specialist	
advice, and ensure their businesses remain efficient and competitive by utilising BCT's services –	ス

our investment in our own network and infrastructure, but continue to focus on our customers'

good position to grow our revenue base and maintain and control our operating expenses, thus
