Heidelberg **Community Bank®**Project Pledge Campaign Launched

The people of Heidelberg are invited to pledge their support for the establishment of a Heidelberg **Community Bank®** Branch of the Bendigo Bank.

The local steering committee, made up of local volunteers, held their official launch party on Saturday 18 October in Burgundy Street to kick off the pledge campaign – the first stage in the process to gauge community interest in the concept.

"Now that a decision has been made to undertake a **Community Bank®** campaign, the local committee will seek indicative pledges of support from local residents, traders and business people," Mr. Purchase said.

"A pledge of support is an indication of the number of people who would be prepared to become a shareholder in a **Community Bank®** branch..." Mr. Purchase said.

A pledge target of \$850,000 from more than 300 people has been set for the Heidelberg campaign. Since the official launch date, the committee has already received over \$350,000 in pledges from over 75 members of the community.

Bendigo Bank currently supports over 220 **Community Bank®** branches throughout Australia, with some returning over \$30,000 per month to their community. The most successful **Community Bank®** branches throughout Australia have collected pledges of support from between 400 and 600 locals, with these people going on to become shareholders in the local company.

Under Bendigo Bank's **Community Bank®** model, once the pledge and feasibility processes have been complete, the community raises share capital via a public share offer.

What is a **Community Bank®** branch?

The **Community Bank®** concept was developed by Bendigo Bank to provide communities with the certainty that banking services and access to funding will be available locally.


The revenue generated by the branches will be split 50/50 between Bendigo Bank and the community Company.

From the community Company's share of revenue, we pay for all local expenses such as electricity, rent and paying staff. Whatever is left is profit. The community Company decides how they spend those profits. A percentage of the profits will be directed to community projects and in dividends to local shareholders. No more than 20% of the profit can be distributed to shareholders.

- The Banyule Community Health Service received \$6,800 for their early years project – providing computer, library and play equipment.

The branch also supports a broad range of sporting, social and community groups, schools and kindergartens across East Ivanhoe, Viewbank, Rosanna and Heidelberg through its sponsorships.

And the success continues....

The success story of the East Ivanhoe **Community Bank®**Branch is not limited to the support of the local community.
