Good Evening Ladies & Gentlemen welcome to the LCFSL 2010 Annual General Meeting.

Having just completed our seventh full year of trading as a **Community Bank**® in Logan City it is with great pleasure that I am able to report on a vastly matured and highly successful business when compared with our conversion on 1 June 2003.

I feel extremely confident of our current financial position, having survived the recent economic climate we have managed to achieve acceptable profits for the 2009-2010 financial year. This has all been achieved with the inclusion of opening our fifth branch in Beenleigh.

As was reported at last year's AGM, we set out this financial year with some very ambitious growth targets.

When these targets were established there was no comprehension of the affect the global financial crisis would have on the Australian economy over this last financial year. However Logan **Community Bank**® group can report that we grew our 'funds under management' (business) by \$15M during the 2009/2010 financial year giving us a closing balance of \$291M in banking business. This equates to a growth of 6% on the previous year's balance.

We are extremely happy to have recently announced to our shareholders an 8 cent per share dividend payment to be paid later this month. It is of the utmost importance to us that at all times we are committed to providing our shareholders a return on their investment. We thank all of our shareholders who have been supportive both through continuing to bank and engage with us during the past year.

It is also my pleasure to inform you that the Logan Community Banking group is now consistently returning a profit each month, this has allowed us to give back to our community some worthwhile investments and support over the past twelve months.

Suicide Awareness – co-ordination of a discussion group session to research ways in which we can assist in helping to raise awareness of this issue

Our biggest investment yet has recently taken place with the purchase of a 24 seater bus for the Logan City PCYC to be used as part of their ongoing commitment to the youth of our city – keep an eye out for the big RED BUS!

Moving forward with our correct procedures & policies in place this will ensure we will sustain our current growth & profit expectations. With still much uncertainty of many large worldwide countries I feel very confident that our banks are positioned in such a way that it will not negate our progress. We will continue to implement change & strategies in order to maintain our position but also need to continue our pro active approach.

Much of the success is contributed to our staff and it is a sincere thank you to Area Manager, Drue Hutchinson and his team for their enthusiasm and commitment during the year.

My fellow Directors; a remarkable group of advocates that continue to uphold the principle objectives of our company and as custodians of a \$291million company they remain commendable, competent and passionate.

A few changes took place within the Logan **Community Bank®** Board with Ian Pynor retiring after a number of years as our Company Secretary and Darren Cahill resigning as Director after receiving a well deserved promotion within the Bendigo and Adelaide Bank Ltd network.

Thanks also to our Administration staff, Manager, Michelle Todd and Assistant Donna Duncan for their efforts in ensuring the smooth operation of the company and branches.

Not to forget the continued support from our partners Bendigo and Adelaide Bank Limited.
