• Director Remuneration

Allan Grundy invited discussion on the subject of Director Remuneration, and mentioned that a couple of Shareholders have expressed concerns.

Richard Doig (Shareholder, Mount Evelyn and Districts Financial Services Ltd) spoke and raised the following points

- Concerns with the information in the policy. The Board has always had a Policy not to be remunerated. In Bendigo's philosophy they represent the Community. Why change? Will community grant processes and amounts change? Suggest no change. Call to reject the proposal.
- -Query amount \$2000 per annum. Directors took on Directorship as a non –paying position. There must be strict guidelines. There has been no shareholder involvement to approve any rules as to the amount being paid.

Allan Grundy replied

- -amounts in the letter to shareholders are indicative and will be in every annual report.
- -Board procrastinated over decision for a long time.
- Board looked at the targets reached and the efforts to date. Some have been involved for nine years.
- -Director Remuneration is meant as a small reward for the time and effort.
- -Director Remuneration may be enhancing to entice new directors.
- -Amounts will be variable and indicative.
- -Bendigo and Adelaide Bank Ltd has a viewpoint not a policy.
- -This proposal is not unusual and will be 100% transparent.
- Policy is to be ratified by board and must have a minimum of six months on Board and attend 75% of meetings. This will allow directors to attend workshops, forums and conferences and the end results are benefits to shareholders.
- -The Board of Directors are not here to make money out of the company.

Allan Grundy moved that the Board proceeds with a Director Remuneration policy. If the motion is passed, the Board will develop and instigate a Policy with strict guidelines and adherence to Director's duties and obligations. Remuneration will be paid accordingly. The remuneration amounts will vary from year to year, but must be affordable after all other considerations. The amounts will be clearly detailed in each and every Annual Report.

• Partnership Forum

This initiative involves essentially the collaboration of the region's **Community Bank** ® Branches, Bendigo Bank Regional Office - Yarra Valley Region, Shire of Yarra Ranges, State and Federal Governments.
