Chairman's report

Annual General Meeting

On 20 November 2008, the third Annual General Meeting of Rosewood and District Financial Services Limited was conducted. The Annual Report was accepted and the motion to accept the Remuneration Report was passed. Helen Suthers' appointment as a Director to replace Kenneth Savage, who resigned in February 2008, was approved by the meeting. In line with the Company's constitution, three Directors namely Eirys Heit, Melissa McGeary and Clyde Nicoll retired as Directors and offered themselves for re-election. The meeting approved their re-election in each case. As Chairman of the Directors, I gave those present an update of the progress of the Company since 1 July 2008 to early November 2008. It was very pleasing to see the number of accounts has continued to increase along with the portfolio which was just over \$92.6 million in early November 2008. This large increase was mainly due to a large Treasury deposit of \$50 million plus the lending portion increased by 21% during this period. After the meeting, the Directors had the opportunity of mixing socially with the shareholders who were present.
