Having come from a Bank of Adelaide background, they were eager to find out what makes the **Community Bank®** model and in particular the Rye & District **Community Bank®** Branch so successful.

Peter Van Duren, Chairman, and Gary Sanford, Senior Manager of the Rye & District and Dromana **Community Bank®** branches, met the group at the Rye branch and showed them a CD presentation on what community banking means and what Rye has achieved since opening in 2001.

They presented the following information:

The Rye & District **Community Bank®** Branch is operated under a franchise agreement with Bendigo Bank, which allows income to be generated to a locally owned community Company, through banking products and services.

- · All products and facilities are provided by Bendigo Bank Ltd
- Up to 20% of the companies profits are returned to shareholders
- Up to 80% of profits are returned to the local community
- The local Company, Rye & District Community Financial Services Ltd (R&DCFS Ltd) is owned by 556 local shareholders
- The Company is currently managed by a Board of 10 Directors
- Further new Community Bank® branches on the Mornington Peninsula are being considered at Balnarring, Hastings and Mt Eliza
- Funding from the Rye branch back to the local community over the last three years has been;
 - \$330,510 in 2005
 - \$428,223 in 2006
 - \$396.000 in 2007

Major projects so far have been;

- Portsea Camp \$100,000 Commitment over 10 years
- · Rye Youth Centre \$425,000 over 5 years

- Community grants \$508,000 to 123 local community groups
- Local schools \$470,000 to 6 local primary schools, including \$300,000 to Tootgarook Primary School Community Hall project
- Sponsorship & donations \$800,000 to approx 200 community groups

Total funding & commitment, approx \$2.3 million

All this has been from one **Community Bank®** branch since 2001. Since 30 June 2007, the local Company has operated a second franchise agreement with Bendigo Bank with the opening of Dromana **Community Bank®** Branch. Dromana **Community Bank®** Branch has received tremendous support from the local community and in less than eight months is already generating new funding into the local community.

The **Community Bank®** model allows the local community to generate its own wealth and provide much needed financial support to community groups. By just moving their banking to the Rye & District and Dromana **Community Bank®** branches, this helps generate additional income which in turn benefits the local community.

The group took a visit to the Rye Youth Centre, which is operated by the YMCA as a joint partnership. They also visited the Tootgarook Primary School Community Hall, a major project which is funded in part by \$300,000 from the Rye & District **Community Bank**® Branch.

The presentation and visit to some of the local projects left Jamie McPhee and his colleagues in no doubt of the potential of the **Community Bank®** model and they left suitably impressed.
