## FOR PUBLIC RELEASE

Heritage's fully owned subsidiary, Coromandel Gold Limited has sold the major part of its holding in Cadmus Technology Limited (CTL) to private investors through JB Were (NZ) Limited. A total of 17,176,233 shares was sold for 6 cents per share. The net proceeds of approximately NZ\$1 million will be mainly used to further Heritage's exploration work, including drilling on its gold projects in the Waihi district.
